***Please initial beside each item below (ALL items must be initialed for participation.)***

\_\_\_\_\_**MONTHLY PAYMENT/LATE FEE:** Tuition is due by the first day of each month. I understand that if my tuition payment is not received by the 5<sup>th</sup> day of the TUITION MONTH (as set forth on the MGA Payment Calendar), then my account will be charged a TEN DOLLAR (\$10.00) late fee, due and payable immediately along with the respective TUITION MONTH payment. Any late fees assessed become part of TUITION, for the intents and purposes of collection. TUITION may be hand-delivered to the MGA Front Desk office assistant, dropped in the Front Desk "Drop Box", or mailed to: 208-A Computer Drive, Smithfield NC 27577.

\_\_\_\_\_**AUTO DRAFT:** I understand that my credit card information will be kept on file at MGA for the purpose of account settlement. If TUITION is at least thirty (30) days overdue, and no special payment or withdrawal arrangements have been entered into between "MGA Management" and "Parent/Financially Responsible Party" during this 30-day period, then the overdue TUITION amount may be rightfully and automatically drafted from the credit card on file, in addition to any late fee accrual. We reserve the right but not the obligation to prohibit participation in MGA programs due to unpaid and/or habitually overdue TUITION.

\_\_\_\_\_**PRO-RATING TUITION:** TUITION is not based upon attendance, but instead on "ENROLLMENT". As long as your child is enrolled in class, full monthly tuition is due in accordance with the MGA Payment Calendar. Tuition may not be pro-rated.

\_\_\_\_\_**REFUNDS:** MGA has a "no refund" policy regarding ALL registration and monthly tuition fees. The only policy exceptions for consideration are: (i) medical disability, accompanied by a doctor's validation, or (ii) medical reasons, requested in writing, prior to the start date of the season. If the student has participated in at least one class practice during that TUITION MONTH (as set forth on the MGA Payment Calendar), then there is no refund option for that TUITION MONTH.

\_\_\_\_\_**MAKE-UP CLASSES:** For your convenience, gymnasts are permitted to make-up one (1) missed class per month, regardless of the number of classes missed. Gymnasts wishing to make-up a class *must* sign-up in advance at the MGA Front Desk.

\_\_\_\_\_**WITHDRAWAL:** Please be advised that MGA policy dictates "thirty (30) days prior written notice" before your tuition obligation is relieved. Your child may certainly attend during this 30-day notice period, however, your tuition obligation remains in effect whether or not your child attends class.

\_\_\_\_\_**"GYMNASTS ONLY" in the gym:** Parents are not permitted in the gym area at any time. The only exception to this rule is for parents who are actively registered and participating in our "Parent & Tot" class.

\_\_\_\_\_**PARENTAL OBSERVATION:** Parents may observe gymnasts during class from our lobby area, or from outside (via the windows). Parents are not required to stay at the facility during their child's class, but agree and acknowledge that they will pick-up their child ON-TIME (subject to a late fee equal to \$1.00 per minute for each and every late minute, beginning after the "five minutes late" mark). Furthermore, parent agrees to leave an "immediate contact" phone number with the MGA Front Desk before departure, for the occasion of illness or injury.
