In accordance with the schedule of Morgan's Gymnastics, LLC, the tuition for _____ hour(s) per week is \$ _____ per **four week tuition period**. After the 5th day of the **tuition month**, a \$10.00 late fee must accompany the late tuition. All checks returned to Morgan's Gymnastics, LLC will be charged a \$25.00 processing fee. If for some reason the monthly tuition is not received by the end of the **tuition month** as shown on the Payment Calendar, Morgan's Gymnastics reserves the right, but not the obligation, to bar the student from class(-es) until such time, if any, that the arrearage is voluntarily remitted by parent/legal guardian, and the account is in good standing. To terminate the enrollment contract with Morgan's Gymnastics, LLC parent/legal guardian must provide written notification thirty (30) days before the first scheduled lesson of the next month. If no written notice or tuition payment has been received by MGA by the last day of the **tuition month**, the monthly tuition amount may be automatically debited from your credit card account by MGA office staff.
